2. Personal Data Collection

We collect the following types of personal data based on your interaction with us:

a. Newsletters:

Optional: Name, Email, Industry, Company Name, Country

b. Webinar Registration:

Required: Name, Email, Job Title, Company Name, Industry, Country

c. Contact Forms / Lead Capture:

Required: Name, Email, Job Title, Company, Country, Phone, Message Content

d. Communications:

Any data included in email or chat interactions, including your name, email address, and the content of your messages.

3. Use of Personal Data

We collect and use personal data for various purposes as outlined below:

Newsletters: We use your personal data to send marketing communications and newsletters. This is based on your express consent, which you may withdraw at any time.
